## INSTRUCTIONS FOR COMPLETING THIS FORM

Question 1: A company or partnership applying as a brokerage must attach a copy of the constating documents, i.e. Articles of Incorporation or Partnership agreement. If the company was incorporated more than one year ago, the brokerage must also attach a certificate from the Corporations Branch confirming that its registration as a corporation is in good standing in Manitoba.

Question 2: If the brokerage proposes using a business name other than its own, that business name must be stated in this question and proof of registration of the business name under *The Business Names Registration Act* must be attached.

Question 3: Business Address means the brokerage's principal place of business in Manitoba. <u>Please note</u> that a brokerage may not operate out of the same office as another real estate brokerage or a lawyer without the Registrar's written permission.

Question 4: Address for Service is the brokerage's mailing address in Manitoba referred to in subsection 2.17(1) of Real Estate Services Regulation 84/2021.

Question 7: The financial year must fall on the last day of a calendar month. If at any time the year-end is changed, the Registrar must be advised in writing immediately of the new year-end.

Question 8: A branch office is an office other than the brokerage's principal place of business that is used on a regular basis for the purpose of providing real estate services. A broker or property management manager may be appointed to be in charge of only one office unless otherwise permitted by the Registrar.

Question 10(a): Attach a completed Letter of Direction (form supplied by the Registrar) for each trust account on which interest is payable to The Manitoba Securities Commission.

Question 15: The Certificate of Membership or Surety Bond (as applicable) must be written in the full legal name of the brokerage including any business name. The amount of bonding a brokerage is required to obtain is set out in Sections 2.23(1) to 2.23(3) of the Real Estate Services Regulation.
